SFY 24/25 Health First Colorado Dental Rate Increase

We are excited to announce new rate increases beginning July 1, 2024! The Colorado General Assembly has approved the Department of Health Care Policy and Financing's targeted dental rate increases in the 2024 budget legislation. The targeted dental rate increase will take effect on July 1, 2024. Specifically, 15 preventive, endodontic and periodontic dental codes will be increased to 100% of 2020 ADA Survey of Fees benchmark, while rates of diagnostic and crown dental codes will be increased to 70% of the benchmark.





All dental codes that did not receive the targeted rate increase will be eligible for a 2% rate increase beginning July 1, 2024. However, dental codes subject to the targeted rate increases referenced below will not receive the 2% increase. This 2% across-the-board rate increase will be applied across all fee-for-service Medicaid provider types starting July 1, 2024, excluding rates for rural health clinics, rates and Federally Qualified Health Centers

IMPORTANT NOTICE: DentaQuest and HCPF are working together to finalize the fee schedules and update DentaQuest system in a timely manner. Unfortunately, we do not have all the information at this time which means that claims submitted with a date of service of 7/1/2024 or later will require reprocessing. To ensure your claims will be appropriately reprocessed, continue submitting them using your UCR.

Dental Advisory Committee (DAC)

Did you know that DentaQuest has a Dental Advisory Committee (DAC)?

DAC is a volunteer committee that meets to discuss policy overall. Feedback from this committee is then provided to HCPF. This forum is not meant to discuss individual claims questions as that should be done with your local Network Manager. The committee meets once every quarter on a Friday morning (Virtually), for 1.5 hours. Topics are requested prior to each meeting to be discussed at the meeting.



DentaQuest strives to ensure all specialties are represented, and effective July 1st, 2024 DAC members will have a 5 -year commitment (term limit) with the option to terminate early because well... life happens!

DentaQuest invites all provider specialties, however, the below specialties are needed.

- Endodontist
- Oral Surgeons
- Dental Hygienist
- Periodontist
- Prosthodontist
- Dental Anesthesiologist


Dental Home Panel Roster via Provider Portal


1. Click on the Member tab


