Silver Diamine Fluoride – Added Benefit Effective 9/1/2020

As part of our value-added service offerings, effective September 1, 2020 Silver Diamine Fluoride (SDF) will be added to CHIP and Medicaid as an extra benefit to members. Silver Diamine Fluoride (SDF) limits the progression of some cavities, providing a painless, non-invasive, efficient treatment for caries arrest.

Details of the value-added benefit are as follows:

- CDT Code D1354
- Reimbursement Rate \$14.12 per tooth
- Limited to ages 6 months to 6 years old
- Two applications, per lifetime of tooth
- 30 days minimum separation between application dates
- Not allowed on same day as D1206 or D1208
